- B. SSCCC Resolution writing training and implementation (25 minutes) (RAD I Hill and VPRA Galianto)
 - a. RAD I Hill and VPRA Galianto will present about the resolution writing process for the General Assembly.

- RAD I Hill presented on what is the purpose of the resolution and how it affects the advocacy of the SSCCC
 - Part 1: Background: 4 whereas, must be succinct and not exceed 1
 page
 - Part 2: The Action: 4 resolves, what actions are you requesting to be taken, must make sense as to what is being asked
 - Resolutions about Legislation Focus more on principles and concepts within legislation, if bill number referenced, must have specific date
 - Attributes of a good resolution
 - Succinct, concise, clear,
 - Thought out
 - Addresses the issue
 - Solve the problem
 - Additional info
 - Proper form (4 whereas, 4 resolved or less, 4x4)
 - Appropriate signature (sponsored)
 - Legible, in electronic form
 - Time sensitive, must be submitted on time

 - Trustee E. Lacorte advised the caucus, the Student Trustee gained voting ability for future Student Trustees at their school.
 - Microaggressions, discrimination, harrassment against Trustees on Board Meetings
 - Trustee M. Cooper: made a comment/requested assistance to address the situation at their district
 - Overnight parking for students experiencing housing insecurity
 - Workgroup for student trustees status update was provided
