PRESIDENT'S UPDATE

Hello fellow student leaders and community,

We made it to the end of yet another long but productive year! I am immensely proud to have served as the VP of Communications, Executive VP, and President during a year where there were extensive strides made to prioritize the student experience. On behalf of the SSCCC, I want to thank all of you for your dedication to advancing student access, engagement, and equity in the system (and on your campuses). This year we were able to implement changes to incorporate Diversity, Equity, and Inclusion into the very fiber of our California community colleges. Student leaders across the state have continued the work to implement the changes that respond to student needs identified in both the SSCCC Anti-Racism Plan of Action and the resolutions many of you wrote in past years!

Below you'll find actions that the SSCCC has taken and wins we've made together:

- Participated in the development of DEI Competencies in Employee Evaluation & Tenure Review regulation changes
- Participated in the development of Campus Climate and Safety regulation changes
- Created draft language for a simpler, more fair Student Grievance Process
- Passage of 24 student written resolutions at General Assembly in April
- Sponsored or Co-Sponsored nine Assembly Bills this legislative cycle

In response to a webinar held to develop the Anti-racism Plan of Action, the SSCCC worked with system partners to develop a Student Grievance Model Policy. In the words of VP Jack Hill, the Model Student Grievance Policy, "Ensures that students have a clear and effective process for them to seek redress for grievances faced at their college, which is crucial to creating a comfortable campus climate that is conducive to student success. The proposed student grievance policy is a direct outgrowth of the SSCCC's commitment towards promoting student voices as well as advancing diversity, equity, inclusion, and accessibility throughout our system."

On June 8th, the Chancellor's Office held a webinar to celebrate the students graduating this spring and to highlight the journey of students in the California community college system. I was joined by Deputy Chancellor Dr. Daisy Gonzales and Student Board of Governor Member Iulia Tarasova as we engaged student leaders in a series of questions to understand student challenges and necessary changes to improve the transfer experience. Congratulations to SSCCC Vice President Jack Hill (College of the Redwoods), VP of Finance Fiza Syed (De Anza College), Legislative Affairs Director of Region III Darieus Rego (City College of SF) and all students who graduated!

June marks the start and end of Pride Month, where members of our LGBTQIA+ community and allies celebrate as well as elevate both LGBTQIA+ culture and voices all month long. Our LGBTQIA+ students have been a historically underserved population In the California community college system. The SSCCC passed a resolution at General Assembly this past April calling on the organization to provide training to student body associations to deepen their understanding of LGBTQIA+ issues, sensitivity training and how to advocate for LGBTQIA+ students, faculty and staff. Alongside student leaders across the state and on college campuses, the SSCCC is dedicated to being an ally to students of all backgrounds and diverse identities.
