Resolution Process

During the 2023 General Assembly (GA), the delegates will consider resolutions that will guide the SSCCC into next year. Writing a resolution not only brings awareness to what issues your college campus faces, but it also helps guide this organization's legislative priorities and overall focus for the year. Any CCC student can author a resolution, not just a delegate or student body association member. If you have an issue on your campus, you can rest assured that other students are having similar concerns so why not write a resolution. If you're interested, here's the process:

Step 1: Talk to students on your campus to get a consensus of what issues are affecting your student population the most.

Step 2: Start a draft resolution

Step 3: Once you have a final draft of your resolution, it's time to seek sponsorship. You can seek this from SBAs, Regions, recognized caucuses, and the SSCCC Board of Directors.

Step 4: Submit your sponsored resolution 55 days prior to the Spring General Assembly -**02/03/23** with minutes attached containing proof of sponsorship to resolutions@ssccc.org.

If you're interested in authoring a resolution but are unsure how, check out some of the resolution resources on our YouTube Channel. Below is the timeline for resolution submission:

- February 3, 2023 Original resolution submission due - 55 days prior to GA
- February 8, 2023 First resolution package disseminated - 50 days prior to GA
- February 23, 2023 Amendments to resolutions due - 35 days prior to GA
- February 28, 2023 Amended resolution package disseminated - 30 days prior to GA






Region IX highlight
