Below are some activities we have planned:

Elections

We will hold elections for the Executive Officers and Regional Representatives. The positions open are:

- Executive Officers: President, Vice President, Vice President of Regional Affairs, Vice President of Legislative Affairs, Vice President of Finance, and Vice President of Communications
 - The last day to submit your Intent to Seek Office for an Executive position was February 24th, but you can run from the floor on Friday, April 4th.

- Regional Officers: Regional Affairs Directors, Vice Chair, Vice President of Legislative Affairs, Treasurer, Communications Officer

RESOLUTION NOW AVAILABLE!

The Spring 2025 Resolutions will be available by Friday, February 28th, on our website at this link! This year, we have more resolutions than ever in the history of the SSCCC – over 70. We highly encourage student body associations to review the resolutions with your colleagues so that your delegates are prepared to vote on April 5th and 6th during the General Assembly in Los Angeles. There's still an opportunity to amend the resolutions. Attend a Webinar on March 5th via this Zoom link and submit any amendments by March 7th.

Accomplishments - Fire scholarships

The recent fires in Southern California profoundly impacted many California community college students. In response to the widespread devastation, SSCCC established a Disaster Relief Scholarship to assist students directly affected by the fires. We received over 500 applications, and after a thorough review process, 25 students were selected to receive financial support. As of February 19, we have awarded 16 scholarships totaling \$12,300.

To qualify for the scholarship, students needed to meet the following criteria: enrollment in at least six units, submission of evidence showing direct impact (such as photos, receipts, or an evacuation notice), and for scholarships exceeding \$500, a completed W-9 form. Scholarship amounts ranged from \$250 to a maximum of \$1,000.

The Disaster Relief Committee carefully considered each application, considering the student's personal story and the extent of their loss, to determine the appropriate scholarship amount. So far, two rounds of distributions have been completed, and the committee will convene to select additional recipients.

Legislative Priorities

The SSCCC Board of Directors recently took action on its legislative priorities. Below is a list of the bills, the SSCCC will sponsor or cosponsor.

- AB 409 (Arambula) will permanently codify our previous legislation, AB-1855 (Arambula), into law. This ensures students can participate in student government meetings remotely without being required to disclose their public addresses.
- SB 98 (Perez) mandates that schools and college campuses immediately notify students, parents, faculty, staff, and community members if immigration officers are present on the premises.
- SB 271 (Gómez Reyes) will help student parents access financial aid, childcare, and other essential resources. It expands the definition of childcare within basic needs services and ensures coordination with the Child Care Local Planning Council and local Resource and Referral agencies to assist student parents in securing subsidized care. The bill also requires basic needs centers, financial aid offices, and child development centers to inform student parents about all available campus resources.
- AB 335 (Gipson) would establish the
 Designation of California Black-Serving
 Institutions Grant Program as a competitive
 grant program to provide academic support
 to underserved Black and African American
 students and other underserved students.
 The bill would appropriate \$75,000,000 from
 the General Fund to the Designation of
 California Black-Serving Institutions Grant
 Program Fund to award grants to California
 State University campuses and community
 college districts that apply for grants.

Conference Report

Jerry Reyes - RAD Region V: My key takeaways were the need to stay informed on federal policies, support for undocumented students, and the value of connecting with peers to advocate for all students.

Annie Koruga - We need to continue to monitor and react to changes in the federal gov while California is generally working to protect students.

SSCCC Stands in Support of Undocumented Students and Mixed Status Families

The SSCCC recognizes the challenges faced by undocumented students due to recent executive actions and the difficulty of staying informed in these uncertain times. We are fully committed to providing consistent support by actively gathering crucial information and advocating for their rights and access to education.

The SSCCC stands in solidarity with undocumented students and mixed-status families in the California Community College system, who are disproportionately affected by federal policies. Many students face fear and anxiety about their safety, education, and future. Our unwavering commitment is to advocate for DACA recipients and immigrant students seeking a better future through education.

We will continue collaborating with the University of California (UC), California State University (CSU), and the California Community Colleges Chancellor's Office to ensure unified support for affected students. Additionally, we will work with legislators to pass policies that protect the educational opportunities of all students, regardless of immigration status.

Our commitment is outlined in <u>Chapter 4 - Anti-Racism: A Student Plan of Action for Undocumented Students</u>, where we affirm that every student deserves the opportunity to succeed. Together, we will work for a more inclusive and equitable future for all.
